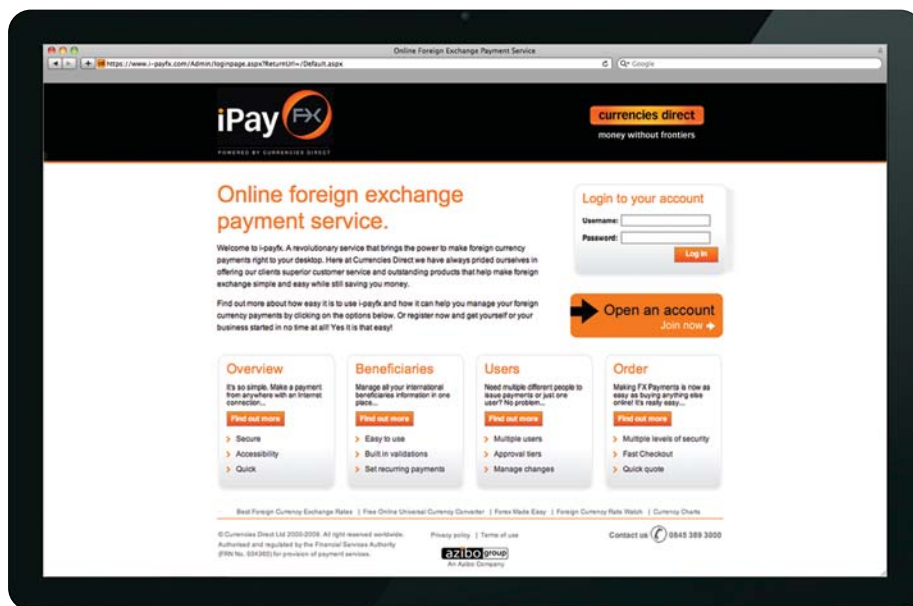

Our **online payment platform** offers 24/7 online access to cross border transfers so you can make payments when it suits you.

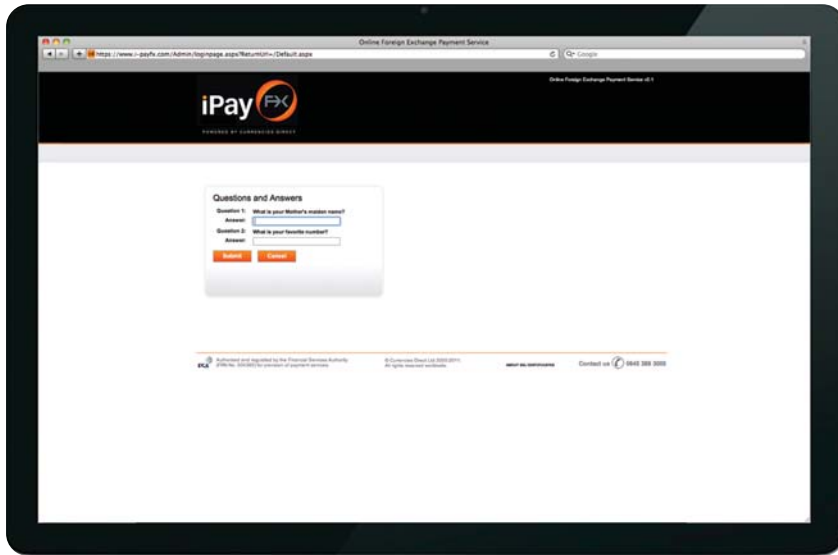

You can store your beneficiary details on the system, making regular online payments quick and easy to complete. You can add new beneficiaries or edit existing ones whenever required.

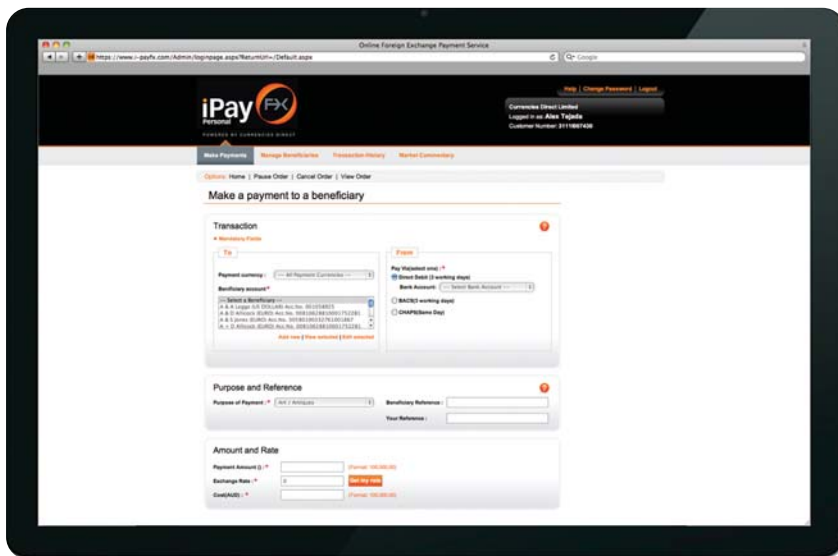

01: Secure access

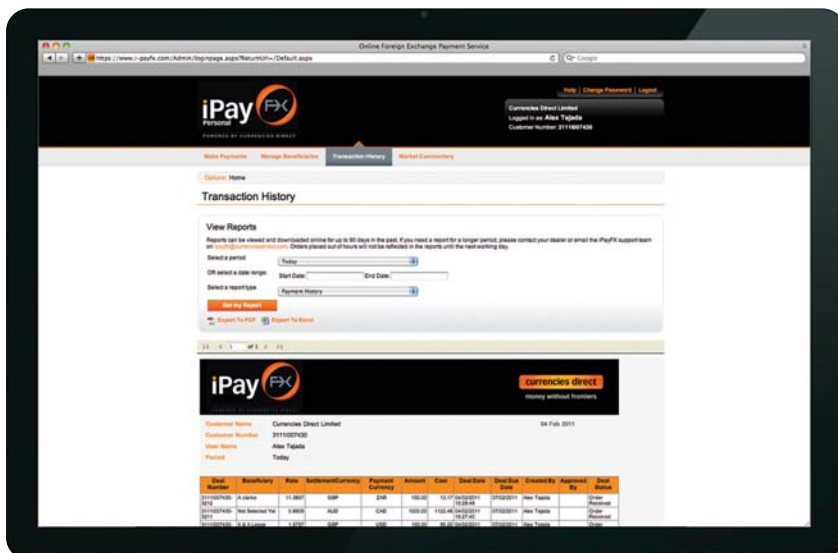
